Director Weigel asked for more information on the Valdivia rodeo. CEO Quaid commented on it briefly (When Mr. Amelio joined the meeting later on, he added to the event).

XII. CEO Report

Explained that we received a letter from WFA and CFA in response to discussion that has been going on for a few years with the State Fire Marshal. At this time, they were talking about bringing proposed changes to all Fairs which include a substantial number of fire marshals at each event. Fairs have all sent letters to their congress people and their assembly people, which we did. Subsequently, the hearing was scheduled for the 23rd, but the Fairs came out in such force and took advantage of the platform that they cancelled the hearing. We are hoping they will rescind this and go back to what is a semi reasonable charge for us and our clients.

Sarah Pelle commented that the State Fire Marshal decided to not move forward on the rule making and cancelled the public hearing. So, at this time they are not moving forward

- Our contract with Zen Zen will start July 1st if all legal issues are worked out. They are really excited about coming here to operate the Derby Club.
- Ventura Raceway started their races June 5th and they have been very successful for the last three weeks.
- Reminded and encouraged the directors to complete their trainings.
- We received our targeted support check which is supposed to cover several things that we requested. We also received the last of the money that is coming from the state.
- We have a couple rentals that are strictly storage, the Rubicon and the Jurassic Quest.
- Mr. Giammanco had his last concert for a few weeks and when he comes back Concerts In Your Car will then change to Surfer's Pint Concerts. While his stage is still out in the parking lot, he is still paying the rate negotiated for not having any activity.
- There are a lot of people requesting dates for activities that they had to cancel in prior years and we are working hard to move everyone around so we can accommodate all the different events that want to come back to the fairgrounds.

XIII. President's Comments

- As far as the Director's Meeting that will take place, there has been some feedback through CEO Quaid as to what things want to be addressed but encouraged the directors that when they do hear from Ms. Bailey-Findley to let her know anything the directors want to be considered or discussed. It is not being called strategic planning because sometimes that just gets filed on a shelf and not followed up upon properly. It is being referred to as the Recovery and Operational Plan. This will help the Board focus on moving forward through everything.
- She stressed to the directors to get up to speed on the trainings.
- She is excited about all the things happening on more of a long term basis, particularly with Surfer's Pint and The Derby Room.
